



REQUEST FOR ADMINISTRATIVE HEARING APPLICATION FORM

Pursuant to Title 10, Section 10.04.075, of the Los Angeles County Code, any party who has been served with a Notice of Violation and Administrative Fine (Administrative Citation) may request an administrative hearing before a hearing officer to contest the imposition and/or the amount of the administrative fine. The request must be filed with the Department within thirty (30) calendar days following service of the citation and must be accompanied by a deposit equal to the full amount of the administrative fine.

Required items for this request (Application will not be accepted if an item is missing):		
<p>A. Completed Request for Administrative Hearing application. B. The request must be received by the Department within thirty (30) calendar days following the date of service on the Notice of Violation and Administrative Fine (Administrative Citation) at any County Animal Care Center or by mail. C. The grounds forming the basis for the hearing request. D. A deposit equal to the full amount of the administrative fine or a signed request for hardship waiver. (Make checks payable to "County of Los Angeles DACC")</p>

At the hearing, you will have the opportunity to present evidence relevant to the hearing officer's determination of the matter. If you do not appear at the hearing the hearing will continue in your absence, the officer's decision becomes final, and you will lose any right to contest the imposition of the administrative fine in a court of law. (LACC, Section 10.04.075)
